Grant support helps restore historic church

First Presbyterian Church of Watertown completes community fundraising effort

A Community Foundation matching grant helped **First Presbyterian Church of Watertown** raise critical support for a more than \$2 million campaign to restore its historic steeple.

The **Rev. Andrew Long**, said a \$50,000 matching grant enabled broad support from the greater community beyond the church membership.

“We’re grateful for the generous support of the Community Foundation and the wider community,” Rev. Long said.

The church is Watertown’s first established house of worship.

The Foundation grant was offered to help encourage non-parishioners to give the effort a boost with a broader community focus.

Philip Sprague, a longtime church member and fundraising committee chair, said the cam-

paigned accelerated thanks to the Foundation’s grant award.

“Unquestionably, we were more successful in raising \$130,000 from outside our congregation when we could talk about the match,” Mr. Sprague said.

The Community Foundation has a long history of supporting historic preservation and recently expanded to providing grants to churches when there is a willingness to actively involve community donors outside of church membership.

Across Northern New York, some of the most prominent and recognizable historic properties are churches. Iconic landmarks such as First Presbyterian Church add character, identity, and beauty to the local landscape and help link the generations together, and we are pleased to support this aspect of community betterment.

LEAD Impact grants broadly support region

Access to personal hygiene products, reducing food insecurity, and supplies for a new commercial soup kitchen are just three of seven initiatives that will receive a share of nearly \$20,000 in grant funding from the Community Foundation's **LEAD Council**.

A recent series of **LEAD Impact Grant Program** awards will support seven tri-county nonprofit organizations. After thoughtful evaluation of nearly three-dozen applications for funding, Council members sought to address current community needs while supporting a wide breadth of organizations whose work improves the quality of life in Northern New York.

"Projects and initiatives proposed by this year's grantees broadly address many strategic needs across the tri-county region," Council Chair **Jessica Piatt Walczyk** said.

The **LEAD Council** is an advisory committee of young professionals empowered to identify and address strategic needs in Jefferson, Lewis, and St. Lawrence counties through community grants and volunteerism.

■ **Children's Home of Jefferson County, Watertown** — \$5,700 to purchase a hygiene products vending machine for its behavioral health clinic in Jefferson County. This initiative aims to provide hygiene essentials at no cost to clients.

■ **Salvation Army of Watertown** — \$3,500 to help combat food insecurity and provide basic human needs for at least 100 individuals and families each day.

■ **Salvation Army of Massena** — \$3,000 to help launch a new commercial kitchen at its Victory Road facility. Funding will purchase new kitchen equipment.

■ **Encompass Recreation, Carthage** — \$2,500 to help lead a newly established Teen+ Club that serves neurodivergent teens and young adults. Funding will help provide a supportive environment for

participants to build social skills, engage in recreational activities, and receive guidance as they age into adulthood.

■ **GardenShare, Canton** — \$2,000 to strengthen food security for vulnerable St. Lawrence County families and promote a local food system. GardenShare removes barriers to access while connecting consumers and producers through equitable food and resource distribution.

■ **Norfolk, Raymondville Food Pantry** — \$2,000 to give the pantry a critical boost to secure more food through the Food Bank of Central New York.

■ **Lyons Falls ALIVE** — \$1,100 to support a coupon program for children to purchase fruits and vegetables at a seasonal market. Lyons Falls ALIVE is a new nonprofit serving Lewis County.

Boxing Club builds charitable support

Celebrating its 20th anniversary, Foundation grant will double impact

As it celebrates 20 years of positive youth development in the region, a \$5,000 Community Foundation matching grant is helping to build charitable support for the **Watertown Area Boxing Club**.

The Club became a federally classified nonprofit organization last year, a milestone that Founder and Head Coach **Johnny Pepe** said had been a goal for several years.

At its core, the Boxing Club provides a safe space for positive youth development, teaching youths from pre-teen through high school ages enduring life lessons that are required for success in and out of the ring.

“Respect is the most important fundamental kids will learn here. Respect for their coaches and fellow boxers, but above all, respect for themselves,” Coach Pepe said. “When you give kids respect, it builds trust



and confidence and motivates them to be better people.”

With respect also comes discipline in a structured environment through which youths of all ages train and learn to perform

to their highest potential in all aspects of life. Boxers also quickly learn that the sport does not condone bullying.

“Respect is everything, and that means combating bullying,” Coach Pepe said.

Coach Pepe is working closely with the Community Foundation to maximize opportunities for fundraising and strengthen relationships as he plans for a sustainable future.

“To have the Foundation and its first-rate reputation behind us is one of the biggest things that has ever complemented our program,” Coach Pepe said. “To step up and support us with meaningful grant funding not only says ‘we believe in you,’ it’s like having an all-star coach in our corner.”

Community Foundation partnership a key driver for five-year-old nonprofit

For HarmoNny Performing Arts Community, the past five years has been a whirlwind journey from idea to upstart nonprofit to envisioning the city's newest venue for the arts through the multimillion-dollar rebirth of the historic Strand Theater with Neighbors of Watertown.

Co-founders Joseph and Shannon Foy are quick to credit their success to a Community Foundation partnership that began as HarmoNny was organizing. The partnership continues to grow through endowment and agency funds at the Foundation.

Before it was established, founding board members turned to the Foundation for guidance to help navigate the steps required to become a nonprofit



organization. Mr. Foy credits conversations with Foundation leadership for helping to put HarmoNny on the fast track to incorporation and eventually

obtaining its 501(c)(3) status.

"We made sure to share our vision, which included establishing a performing arts venue centered in Watertown," Mr. Foy said. "This led to the Foundation referring us to Neighbors of Watertown Executive Director Reg Schweitzer who was looking for an organization to run the Strand Theater."

As a result, HarmoNny, together with Neighbors of Watertown, opened the newly renovated space in January.

Community Foundation grant funding has helped set the stage for the Strand as a professional venue. A \$10,000 grant was used to purchase and install the house sound system, and \$5,000 in Youth Philanthropy Council

funding secured a projection system that will permit a wide variety of events.

"Having a house sound system means that we are taken seriously as a venue," Mr. Foy said.

Grant funding totaling \$8,000 from the Foundation's LEAD and Youth Philanthropy councils has also helped HarmoNny develop a musical instrument lending library that offers music students and aspiring performers a chance to check out an instrument for a period.

"We passionately believe that our presence in downtown Watertown fills a much-needed space for this community, and we are thankful that the Foundation believes in our mission and vision," Mr. Foy said.

"We are deeply grateful to have the Community Foundation in our community — and now as neighbors. HarmoNny would not exist as it does today without its assistance."

Improving accessibility for all

Foundation grants support capital projects at three libraries

A pair of Community Foundation grants totaling \$55,000 will support accessibility improvements at two public libraries in Jefferson and St. Lawrence counties.

Hay Memorial Library is a community hub in the Village of Sackets Harbor. More than 17,000 visitors participated in programs last year, used and borrowed resources, or obtained computer or Internet access.

Library officials have been eager to construct a safe, modern entryway for all patrons, regardless of mobility. Installation of an interior lift and structure is planned to protect it.

The Community Foundation recently awarded a \$25,000 grant to help the library with the estimated \$290,000 project.

“Having the Community Foundation as a major partner for Hay Memorial Library’s ‘Welcome, All’ universal accessibility project will have a positive impact on every person who comes through the entryway of our community library,” said **Christine Eggleston**, Board of Trustees president. “This support is the very foundation upon which we



are building our local efforts. This grant creates forward momentum and a commitment to upgrade accessibility for all patrons.”

Ogdensburg Public Library has served the community since 1922. Last year, it saw more than 26,000 visitors, presented 230 programs and hosted 100 meetings. After years of temporary repairs, the library is pur-

suing a capital project to install a new handicap accessible lift and sheltered exterior. Patrons have been without handicap access since the existing lift failed last fall.

A recent Community Foundation grant of \$30,000 will help the library with the estimated \$174,000 project. Grant support includes \$5,000 from an individual donor.

“This matching grant is extremely important for the library, as it will help enclose our outside lift to work in all weather,” Executive Director **Penny Kerfien** said. “Ogdensburg Public Library is thrilled to receive this support and to continue our partnership with the Foundation.”

East Hounsfield Free Library was also recently awarded grant support for a capital project to help replace a furnace. A total of \$15,000, which includes a \$5,000 match to build charitable contributions from the community, was provided last fall.

Thirteen public libraries across the region have established permanent endowment funds at the Foundation, which provide an additional source of income to support their missions.

Jonathan "Jono" Burchell was the ultimate dreamer. Not only did he dream big, but he also fully committed to making sure he could make his dreams a reality. It was his unparalleled level of commitment to everything he did that made his many achievements possible.

An accomplished musician, pilot, extreme skier, concert producer, and fishing guide, his life was an inspiration to all whom he knew.

Those closest to him recall his generous spirit. He inspired his peers to live their lives to the fullest and to follow their dreams, too.

His love of adventure and his continued pursuit of his dreams led to his last experience

of which he wrote to his mother: "I am learning the ways of bush flying and spreading my wings in the ways I have always dreamed. Thank you for bringing me into this world to enjoy such things." Jonathan was fatally injured at age 30 in a crash of the bush plane he was piloting in the Kenyan outback in June 2003. At the time of his passing, he was on the staff of the Laikipia Predator Project, tracking, capturing, and collaring lions for research purposes.

He was a graduate of the Fieldston School in New York and the University of Rochester.

Allison McGrath Burchell-Robinson established the **Jonathan Edgar Burchell Memorial Fellowship** at the Community Foundation last year to honor her son and make it possible for those who demonstrate the same spirit and passion, whatever their path may be, to make their dreams a reality.

The fellowship is committed to providing scholarships and/or financial aid to inspirational individuals. Specifically, to assist individuals in their pursuit of education in the fields of environmental conservation, land conservation, aviation, the arts, and live music production.
