aith, family, and service guided Ralph and Joan LaClair throughout nearly 50 years of marriage while raising five children in Northern New York.

Ralph, a proud U.S. Army veteran who served in Okinawa during World War II, built a successful career in insurance as president of Howland-La-Clair Associates. Joan, a Registered Nurse, cared for countless patients at Watertown hospitals and later in private practice.

Together, they lived their values by giving generously of their time and resources to strengthen their community. Whether through civic organizations, professional service, or quiet acts of kindness, the La-Clairs worked to make life better for their neighbors in need.

Ralph passed away in 1998, followed by Joan in 2006. In 2022, the **Ralph and Joan LaClair Family Fund** was created at the Community Foundation.

## Protecting your wishes in a will matters

will gives you the power to provide for loved ones and support causes close to your heart. Many people also choose to extend their generosity to strengthen their community.

That's where the Community Foundation can help. As a trusted steward of charitable legacies, the Foundation ensures your giving remains impactful over time.

The Foundation adapts to changing community needs while honoring your values. You may want to support your library, rescue squad, or animal shelter. But what if the organization closes or no longer needs resources? By working with the Foundation, your intentions endure.

If you pass away without a will in New York, state law decides

who inherits your estate. Assets titled solely to you pass "through" your estate. Those jointly held or with a named beneficiary, like a joint bank account or family

account or family home, pass "around" your estate.

Without a will, the law distributes assets to your next of kin, often in ways that may not reflect your true wishes. For example, a spouse and two children would receive:

- First \$50,000 and half of what's left to the spouse
  - Children split the remainder
- Courts then appoint someone to manage inheritances for minors or those unable to handle their assets.

Thoughtful planning also helps you minimize probate, reduce expenses, address long-term care concerns, and makes clear your charitable plans so they are properly executed. Ask yourself:

- What do I want?
- How do I get there?
- What legacy do I hope to leave? The Community Foundation and its team of professionals are ready to help you answer those questions and shape a legacy that reflects what matters most to you.

# Choose your gift. Create a plan. Give forever.

There are many flexible ways to leave a legacy to benefit the places and organizations you love the most, during your lifetime or as a planned gift. A gift made through the Northern New York Community Foundation can be powerful and enduring. Consider these smart and effective giving options as you prepare to discuss plans with your advisors:

### Friends of the Foundation

A gift to the Friends of the Foundation Community Betterment Annual Fund supports Foundation programs and helps us remain flexible as we respond to emerging needs across Jefferson, Lewis, and St. Lawrence counties.

### **Bequests**

A bequest is the most common way to support your favorite charities and community in perpetuity. You can leave a specific sum or percentage of your estate in your will or trust to the Community Foundation. The Foundation can provide specific language to ensure your gift is designated responsibly.

### Charitable Gift Annuity

This gift can generate income for you or a loved one and create partial tax savings with the establishing gift and subsequent annuity payments. The remainder reverts to the Community Foundation after your lifetime and can be directed to an endowment the Foundation stewards, or to create a permanent named fund on your behalf.

### Gift of stock or appreciated securities

This option presents tax advantages. Receive a tax deduction and avoid capital gains tax on a stock gift to the Community Foundation. Establish a named fund at the Foundation to support nonprofits of your choice or direct the gift to an existing Foundation fund.

### Life insurance

Many people find that the protection offered by life insurance policies is no longer needed later in life. You can list the Community Foundation as the beneficiary of an existing or new policy to increase generosity in support of your objectives.

### Retirement Plans

By changing the beneficiary to the Community Foundation, you maximize your gift for the charitable goals you wish to see fulfilled. It is a simple and meaningful way to make a difference.

### Qualified Charitable Distribution (QCD)

If you are 70 ½ or older, a QCD to the Community Foundation can be an excellent way to make a gift. Make a distribution from your IRA as part of your Required Minimum Distribution (RMD) to the Foundation and avoid taxes. Then, the IRA distribution to the Foundation may be directed to support an existing fund or to establish a named fund of your own to help local charities of your choice. Distributions to start Donor-Advised Funds are excluded.

### Real estate and other property

This gift can maximize your charitable intentions, help avoid estate taxes, and reduce the burden placed on heirs. The Foundation's gift acceptance policy can help guide the responsible execution of this type of gift.
